

## Request Form for Access/Correction of Personal Data

## **Important Notice to Requestor:**

- 1. Please read these instructions carefully before completing this Request Form for Access/Correction of Personal Data ("Form").
- 2. This Form is to be used by individuals requesting to access and/or amend their personal data held by or under the control of Cheers Holdings (2004) Pte Ltd ("Cheers").
- 3. You are not entitled to access and/or amend data which is not personal data, or personal data not belonging to you. It is an offence under Section 51 of the Personal Data Protection Act 2012 to obtain access/make a request for correction to the personal data of another individual without the authority of that individual.
- 4. Please complete the identification box below clearly, and in detail. Cheers may seek further clarification, or refuse to comply with your request if you have not provided sufficient information as may be reasonably required to locate the requested data. Your request cannot proceed until all sections are completed satisfactorily.
- 5. Cheers will conduct verification process to ensure that Cheers does not reveal and/or amend personal data about another individual. Cheers may require you to produce further identification documents to verify against our records.
- 6. To make a request, you may either:-

- 7. Cheers reserves the right to charge an administrative fee to allow Cheers to recover any incremental costs of responding to your access request ("Administrative Fee"). Unless we inform you otherwise, the Administrative Fee is \$\$10.00 per request. For access to CCTV footage, the charges are \$\$50.00 plus any additional processing costs (for example, costs incurred for masking of 3<sup>rd</sup> party images) (collectively, "Processing Fee"). We will inform you an estimate of the Processing Fee prior to Cheers processing your request. The Administrative Fee and Processing Fee (if applicable) shall be paid by cheque to "Cheers Holdings (2004) Pte Ltd".
- 8. Upon receipt of your request, together with the relevant identification documents and the Administrative Fee/Processing Fee for access to your personal data, Cheers will aim to complete your request as soon as possible, but please allow up to 30 days for us to respond.
